- Change the dimension and material of heat sink (for LD).
- Change the dimension of heat sink (for LCD).
- Remove PW fan.
- Add four thermal conductive sheets on LD driver board.

03. Add below changes for all models.

- Add five holes on metal bracket located above LD driver board.
- Add below changes for power supply B, and no any safety concern is involved.
 - a. Add SMD type capacitors (C262 and C263) for EMI concern only.
 - b. Add reserved copper pads on six parts intended to be used for mounting SMD type capacitors in the future.
- Change the insulation tape of T202 form "DONGGUAN SHIN YAHUA ELECTRONIC MATERIAL CO LTD / CT* (c)(g)" to "JINGJIANG YAHUA PRESSURE SENSITIVE GLUE CO LTD / CT* (c)(g)".
- Add one alternative source of ultracapacitor.
- Change the model of phosphor wheel motor to 17S*****
 (* could be A-Z, a-z, 0-9 or blank; for marketing purpose only.)
